# Teaming Up to Advance Behavioral Health for Eastern North Carolina



ECU Health and Acadia Healthcare announced plans to build a state-ofthe-art, 144-bed behavioral health hospital in the medical district of Greenville, N.C., that will open in spring 2025. This facility will include 24 inpatient behavioral health beds dedicated to serving the mental health needs of children and adolescents – the only such beds within 75 miles of Greenville.

Located within five minutes of ECU Health Medical Center (formerly Vidant Medical Center), the new hospital would be a center of excellence, providing North Carolinians with important access to behavioral health treatment from specialized clinical teams in a carefully designed environment.



### Meeting Eastern North Carolina's Behavioral Health Needs

Nearly 100 years ago, Pitt Community Hospital (now ECU Health Medical Center) was established and has continued to serve an important role as eastern North Carolina's leader in public health. Given the profound challenges facing our state in terms of access to quality behavioral health care, especially in rural communities, there is a tremendous need for innovative strategies to address these challenges.

### Why This Must Be a Priority

Through this potential partnership, ECU Health is reinforcing its commitment to stopping the stigma against people with mental illness. Prior to the pandemic, nearly one in five North Carolinians experienced a mental illness. In the last two years, data\* indicates a growing trend of depression and anxiety symptoms.

## National Trends having a profound effect in our state:

National Council for Mental Wellbeing found a 52% increase in demand for behavioral health services

- **26%** of Americans 18 and older suffer from a diagnosable mental illness each year
  - Suicide is the second-leading cause of death in people between the ages of 10 and 34

The latest CDC research shows symptoms of anxiety and depression have risen by three and four times over the past two years

### In 2021, Mental Health America ranked North Carolina:

- **42<sup>nd</sup>** in adults with any mental illness reporting an unmet need
- **44**<sup>th</sup> in overall access to behavioral care services for adults and youths
- **45<sup>th</sup>** in youths having a higher prevalence of mental illness and a lower rate of access to care



More than **700** children from eastern North Carolina arrive each year at an ECU Health Emergency Department with a primary psychiatric diagnosis.
